2024 Report of Exploring Human Networks to Power Sustainability (WG 51)

WG 51 held four online meetings in 2024 including a pre-PICES business meeting and hosted W3 at PICES AGM 2024. All meetings and workshops were co-chaired by Dr. Shion Takemura (Japan) and Karen Hunter (Canada).

Online Meetings centred around ToR 1 and 2 to finalize data inputs for the methodology and run code to analyse the inputs. Throughout our discussions, we resolved our data input issues (meeting notes detail these) and were successful in running R-code for three sets of data (Japan, Canada, USA) prior to the PICES AGM 2024 workshop organized by WG51.

A. ONLINE MEETINGS

Online Meeting 2

Item 1 Introduction

Dr. Takemura gave a few introductory slides about the working group methods, members, goals, and activities.

Item 2 Country report on ToR1 (China, Korea, USA)

China

Dr. Takemura will follow up with a member directly to request access to or a copy of the data/repository.

Canada

Ms. Hunter has contacted the DFO Library to request a longer time-series of publications and potentially a more comprehensive one. Ms. Hunter will follow up with news from the library. If she is unable to access the additional information, she will begin to amalgamate online data sources from the DFO website.

Korea

Dr. Lee questioned whether fisheries or oceanography work included. WG members agreed to to be as comprehensive as possible to include representation across PICES focal areas. We can always choose specific focal areas later. Dr. Takemura will follow up with a member directly to request access to or a copy of the data/repository.

<u>USA</u>

Dr. Takemura will follow up with a member directly to request access to or a copy of the data/repository. Ms. Hunter asked for clarification on the studied time period. WG members suggested and agreed that 1990 is a reasonable starting year, justified by the PICES organization timeline of existence and an ability to compare outputs from WG51 to PICES outputs (Takemura et al., in preparation).

Item 3

A) ToR1 report (WG51-ToR1-Table)

- Dr. Takemura requested members fill out this table to the best of their ability.
- Ms. Hunter raised questions about whether the spreadsheet is currently clear enough for data entry and future users and if it will capture the available metadata accurately. For example, in draft version, we wouldn't be able to discern metadata for various publication types. Mr. Roman suggested expanding columns for each country to deal with this, but questions remain about what metadata are necessary for this product to be sufficiently useful for WG51 and in the future.
 - → Dr. Takemura: to send the spreadsheet directly to WG51 Chinese members (Prof. Cao)
 - → Dr Takemura/Ms. Hunter: to contact Russian members on HD Committee who are interested in WG51 (Ekaterina and Oleg) directly, cc to Prof. Makino
- Ms. Hunter raised an additional question that we did not have time to address: If the publication information source is NOT in an online repository, what do we do?
- Mr. Roman asked about gathering additional data points from PICES—the last study ended in 2019.

 - → Mr. Roman: to contact Dr. Chiba (PICES Secretariat) to get abstracts

Important notes from discussions:

We will include a broad set of ocean science research in this study. This is to reflect the scope and goals of PICES.

We will include publication data from 1990 onwards where possible.

Online Meeting 3

On May 6/7, 2024, WG51 held an online meeting chaired by the co-chairs. Participants are listed in WG51 Endnote 1.

A second online meeting was held to focus attention on ToR1: Summarize data availability of the database for research activities in PICES nations. Participants reviewed action items and the data spreadsheet for WG members to complete before the meeting to highlight data sources (i.e., a scientific publication repository) and identify questions for discussion as part of their country report. The discussions in this meeting led to a shift in approach for the working group as it became clear that several countries did not maintain an accurate or complete repository of scientific publications produced from government-resourced marine science organizations. We explored other options in this meeting and came up with a set of action items to pursue with WG members' responsibilities identified for each. The meeting also included a discussion about workshop planning for PICES 2024.

Agenda item 1. Introduction

Introduction of WG members and adoption of agenda.

Agenda item 2 - Country report on ToR1 (China, Korea, USA)

- * NOAA's repository is vast. There is considerable metadata. Mainly good for Federal articles, journals, less so for books, conferences papers. 2015 onwards.
- * Korea has a repository for all Korean papers. Lee-san will need to do some work to sort out the comprehensive content that is in the database. Not all international journals are captured in the Korean dataset
- * Karen had a meeting with DFO librarian and will be able to provide metadata, but it is not located in a central repository.

Discussion of strategy for known missing articles in repositories:

* Missing articles from various repositories (e.g., Korea, Canada) can be captured by running a Web of Science search using keywords. We will need to determine what those keywords should be, but we can do that.

Agenda item 3

a) ToR reporting out

Outlining the WG51 Methodology clearly

- Action for a future meeting is to lay out how the data from various countries will be used, and how we will handle different language inputs/keywords/possible quantitative technical issues, etc.
- WG members need to know what format and what exactly they need to do to prepare data for Shion-san to run code
- For WG51 members, first, gather metadata from repository and download it so that Shion-san can run code to extract into .csv formatted into columns
- Metadata downloaded as a .csv is preferable. No need to locate pdfs.

- We need to be clear about keywords are we translating English words used in our Takemura et al. PICES-focused research into other languages? NO we are generating a new list!
- b) PICES 2024 Workshop

We discussed whether we would invite a speaker – Karen + ECOP member - Raphael and Rachel Intersessional SB meeting will happen tomorrow - Makino-san will attend and share our choices. Preliminary analysis with repository data is planned.

 - ➤ ICES is doing similar work can we use Mr. Roman's code?
 - Who can collate the ICES new data? Dr. Takemura to follow up on whether they can help.
 - ➤ ICES database team have finished compiling abstract text database of ICES Annual Science Conference (ASC) from the ICES repository. ICES Science Impact on Publications Group (SIPG) have conducted text analysis for ICES-ASC abstract database (1999-2019). SIPG plan to give a poster presentation at ICES Annual Science Conference 2024.
 - Dr. Takemura and Mr. Roman will follow up.
 - Dr. Takemura will share the ICES Abstract book with Mr. Roman.

a) Data source

- Dr. Takemura is working on an "instruction book" for countries to search in WOS (Web of Science) and generate a reliable list of science publications across fields relating to PICES.
- Canada update that AFSA is not useful for Canada repository generation.
- Ms. Hunter can search WOS and is happy this suggestion seems to have resolved several other issues.
- Dr. Seary used WOS to search for NOAA.
 - ➤ Go into affiliations and find sub-affiliations by clicking on a question mark to identify all the different variations of the center's names.
 - → These procedures are hard. Dr. Takemura suggested that ZIPCODE might be effective in filtering data by utilizing WOS queries.
 - Question regarding what to include was answered with anything that PICES cares about.
- The group did some work live to discover WOS possibilities.

Russia: TBA (TINRO Center and VNIRO?)

USA: NOAA (Alaska/Northwest/ Southwest/Pacific Islands Science Fisheries Center)

C) Rachel hasn't yet shared her **error message** with Shion-yet.

D) Web of Science work

No updates from Karen-san regarding WOS in Canada. Raphael will follow up with Karen on the progress made and the next steps.

Japan and Korea have completed their work (i.e., downloaded WOS databases for FRA, NIFS, and KIOST). They removed content in Japanese and Korean and only retained English publications.
